The customer by signing, understands and agrees that if an open account is established, purchases will be paid according to terms and further agrees to pay 1.5% monthly (18% APR) finance charge on any balance past due. The customer also agrees to pay Heathwood Oil Company, Inc. a service charge of \$25 for all protested checks returned by your bank. The customer further agrees that in the event the account is not paid pursuant to its terms and conditions the customer will be responsible for all collection cost, including all reasonable attorney fees, court costs, repossession fees and/or collection agency fees, together with interest thereon at the maximum amount allowed by law.
- 3. If products are ordered to be delivered to a job site, the customer assumes liability for the products at the time of delivery whether or not the customer's representative is on hand to acknowledge receipt of delivery.

- 5. To avoid paying sales tax, a fully completed and signed Sales Tax Exemption Certificate must accompany account application. If no sales tax certificate is provided, the customer will be charged applicable sales tax.
